***Rules & Requirements
Houston County Fairest of the Fair Pageants***

1. Contestant must reside in Houston County and/or be enrolled in the school system of Houston County.
2. Each "Fairest of the Fair" contestant must be 16 years of age but have not reached her 21st birthday by December 31, 2011 to be eligible for competition. The pageant reserves the right to require proof of age upon request.
3. Contestants will be judged on their On-Stage Question, Beauty, Poise, Personality and a short meet/greet type interview the day of the pageant.
4. A Contestant cannot qualify if she is or has ever been married, had a child or been charged with a felony.
5. Sportsmanship and manners are required for all contestants.
6. Contestants must pay an entry fee of \$40.00. Entry fee must accompany application. **Deadline for entries in the 2011 contest is Wednesday, September 21, 2011.**
7. Dress attire must be Party/Sun Dress or an outfit representing a day at the fair.
8. Only the Contestant and one chaperone will be admitted at no charge to the Fair. Only one parent/chaperone is allowed in the dressing room with the contestant.
9. The Winners of "Fairest of the Fair" must represent "The Houston County Fair" at various events during the year.
10. **ATTENTION Fairest of the Fair:** The Fairest of the Fair will be required to attend the Tennessee State Fairest of the Fair contest at the TN Fair convention January 19-21, 2012. If she cannot attend the State Fairest of the Fair Contest, she must relinquish her crown to the first runner up who will become the new Fairest of the Fair. The winners will be expected to come back and crown the winners for the 2012 pageant. The Fairest of the Fair will receive up to \$300 (\$50 the day of the pageant and \$250 only if they participate in the State Pageant) . Pageant entry and hotel room is paid for by the Houston County Fair for the contest to participate in the State Fairest of the Fair.
11. **Entry Deadline** All entries are due by September 21, 2011. Cash, checks or money orders will be acceptable methods of payment for the fees and must be received with the application. Entry form and fees can be dropped off at the Houston County UT Extension office located in the basement of the Courthouse. Please remember that pageants are a competition and should be for fun. Unfortunately there can only be one crown per division awarded. The Judges decisions are final and the directors are not responsible for who is crowned. We ask that the parents please try to set a good example for your children and use good sportsmanship conduct at all times. Anyone found acting in an inappropriate manner will not be allowed to complete in the next pageant. Thank you for your cooperation!
